

Dear Dr. Durgin,

Thank you for meeting with our family to discuss Margie Warren's health and care Wednesday, March 10th. As Stephanie and I walked with you after the meeting you made the statement that Delisa Patrick obviously loves her mother very much. I think you may have drawn the wrong conclusion.

Delisa Patrick, my sister-in-law, has a high need to dominate and control every situation and everyone around her. Initially she will use a pleasant demeanor and persuasion to accomplish this goal. If unsuccessful, she will use intimidation and bullying, finally escalating to threats of harm. My guess is that she has probably already threatened you with legal action. And I bet some of your nursing staff has been threatened with a statement like, "You better hope I don't run into you in the parking lot after shift or I will..." All this is standard behavior for Delisa and is quite disturbing.

Delisa's behavior is not limited to just you and your staff or a manifestation of the stresses associated with a critically ill Mother. In fact, Mom and Delisa's minor son, are often the targets of this manipulative behavior. In fact, Delisa returned to Mom's room following our meeting with you and began yelling at Mom to declare she wanted Delisa to make decisions for her, not Beverly - Mom's legally designated POA. Delisa's demonstrative behavior is not love nor is it rooted in love.

I also respectfully challenge the notion Mom's necrotizing fasciitis was caused by a long dormant cyst that ruptured. It seems more likely an untreated/mistreated sore, scrape or cut became infected due to poor hygiene and an unsanitary living environment. At the hospital, Delisa stated to the family that she and her daughter, land, had lanced and packed a cyst on Mom's groin. I yield to your professional opinion, provided you knew of and dismissed these possibilities.

Furthermore, in a rare polite call to her sisters, Kim and Beverly, Delisa indicated that Mom was suffering from what she assessed to be an UTI. Additional phone conversations throughout the week preceding Mom's emergency hospitalization and surgeries indicated the infection was getting worse. Delisa's stated plan was to consult the home care nurse the following week. Kim and Bell advised her to take Mom to the doctor or call 911 and get her to the hospital. A couple days later Mom was brought into your ER with a life threatening condition.

Regardless of the origin of the infection, the amount of time that elapsed prior to seeking professional medical attention clearly shows negligence on the part of Mom's caregiver, Delisa. The severity of Mom's wounds attest to negligence and possibly even abuse. There is little evidence of love or compassion in the level of care that Delisa provided.

I would not burden you with this simply to set the record straight. Rather, I have well founded concerns that Mom may be in continued danger by Delisa's constant presence and her defiant, abusive behavior. While I do not believe Delisa will act upon threats she has likely made to your nursing staff, we cannot ignore threats of violence in these troubling times. I do not expect anyone to act upon my words alone but rather my words may assist you in piecing together a more complete understanding of Delisa Patrick and the threat she may pose to Mom and others.

The ambulance took the child to the ER & the hospital determined the hoart murmur had closed some time ago. a couple of days after they returned home from the hospital, DCS showed up. They stated they received an anonymous repeat that she was believed to have had Munchausen & was purposely causing the child to not be able to breath+ then performing CPR on the child. They told her due to allegations, if there wasn't anyone to stay with her + the cheldren while her husband was at work, then they would have to remove the Kids. The chield was around 2 yes old I believe at the time. She called me I told me these details I to Id her I would stay. I ended up there every night my son was at work for months miraculously, the child never had can incident like this again. I think if she had not called 911 so many times due to the child not breathing, she probably wouldn't have had DCS called. But, she always had an emergency with one of the Kids every time her & my son was in an argument before he left for work the worked nights) The cheldren have only had "hoalth problems "when no other adult was around to witness it other than her.

When the same child (as in previous statement) was 5 weeks ald, the child was taken by am bulance to the ER for "not breathing."

Nelisa had stated that she had to get the child breathing a gain while the ambulance was on the way. The chied was admitted for testing for a coupledays.

My son was at work that night a went straight to the

hospital. They needed something from the house of asked me if I would get it a bring it to them. When I went into the home, there was a suitcase

open on the bed with clothes in it. Later, I confronted my son about it & he said they were arguing before

he left for work & he had been packing to leave her.

The child was diagnosed withe reflex.

She also did it to myself also. at any time, I didn't do what she wanted oragneed with ordidn't give them money when they asked, I was cut off from seeing the Kids. as of may 2024, it will be I from 9 yrs. since I have seen my 3 grandcheldren.
